Credit Applications

The credit application is one of the most critical documents in the credit process. Its purpose is 2 fold: firstly a credit application provides a picture of the business or individual under consideration for the extension of credit. Secondly when an account becomes delinquent, it is a necessary and valuable tool in the collection process.

It is impossible and misleading to judge your potential debtors strictly based on appearances or what you think you know. Parmalat, Eaton's, Stelco and Air Canada are prime examples of large Corporations having experienced some form of bankruptcy or restructuring and having experienced some form of bankruptcy or restructuring and hence creditors experienced or will experience a loss. These are examples where prior to well publicized difficulties, most businesses would have provided a service or product on credit and expected to be paid according to terms. The same can be said for individual debtors. You do not know what is contained in a private mailbox or what lies hidden beneath what would appear to be a successful exterior.

On the collection side, without information it is very difficult to collect overdue accounts. What do you do if all you have is a Name? This is a common situation in collections and it is much more difficult to obtain the necessary information after a problem has occurred. When your customers want something from you is the time to get something from them.

There are a variety of applications available and the best alternative is to tailor one specific to your needs. Perhaps you do not need as much information or maybe you want to combine the personal application with the business application if your niche is smaller business. You can also add your terms and personal guarantees to the application if it suits your needs.

Whichever application you employ, make sure you use one and fill each one in thoroughly or you will defeat the purpose. **Your application should include:**

- ◆ Legal name of business (articles of incorporation, business tax registration documents, drivers license, birth certificate) photo copy and keep in the file.
- ◆ Trade names and subsidiaries if there are any.
- ◆ Physical address and billing address.
- ◆ Phone number, fax number and email address and the names and extensions of individuals that would resolve issues.
- ◆ Type of business example Proprietorship, Corporation, Partnership.

- ◆ Date the business started – Statistically 50% of new businesses close within 1 year and 70% close within 5 years of operation (American statistics).
- ◆ Names of principal Officers and the names of the people working in the accounts payable department.
- ◆ Banking and branch information.
- ◆ Three trade/credit references.
- ◆ Ask if there are any unsatisfied judgments, source deductions or GST/PST due.
- ◆ Have a personal guarantee available on your credit file. If the business is newer and or has limited trade references, then insist on having it signed.
- ◆ Take at least 2 personal references on individuals.
- ◆ You can ask for but never insist on social insurance number unless you need the SIN for tax reporting. If a field is present on credit application for a SIN, it must indicate that the SIN is optional.
- ◆ Asking about investments adds to an applicants net worth and could certainly prove useful in the collection process.

Your customers are accustomed to filling in credit applications. Again the objections are probably perceived in your mind and not that of your customer. This is a sign of a professional relationship and should be expected. If your customer refuses it is probably because they have something to hide. You can always give them the option of another form of payment. If you lose them as a result of this, it wasn't likely a deal worth making because you would probably have to collect it.
